NOTICE IS HEREBY GIVEN that the 61st Annual General Meeting ("AGM") of Pacific Century Regional Developments Limited (the "Company") will be held at Raffles Town Club, Dunearn Ballroom III, Level 1, 1 Plymouth Avenue, Singapore 297753 on Thursday, 17 April 2025 at 10.00 a.m. to transact the following business:

- To receive and adopt the Directors' Statement and Audited Financial Statements of the Company for the year ended 31 December 2024 and the Auditor's Report thereon.
- 2. To approve and declare a tax-exempt (one tier) final dividend of \$\$0.0596 per ordinary share for the year ended 31 December 2024.

To consider and, if thought fit, to pass, with or without modifications, the following resolutions as Ordinary Resolutions:

- (2) (subject to such manner of calculation and adjustment as may be prescribed by the SGX-ST) for the purpose of determining the aggregate number of shares that may be issued under paragraph (1) above, the percentage of issued shares shall be based on the total number of issued shares (excluding treasury shares and subsidiary holdings) at the time this Resolution is passed, after adjusting for:
 - (i) new shares arising from the conversion or exercise of any convertible securities or share options or vesting of share awards which were issued and are outstanding or subsisting at the time this Resolution is passed; and
 - (ii) any subsequent bonus issue, consolidation or subdivision of shares;
 - and, in paragraph (1) above and this paragraph (2), "subsidiary holdings" has the meaning given to it in the Listing Manual of the SGX-ST;
- (3) in exercising the authority conferred by this Resolution, the Company shall comply with the provisions of the Listing Manual of the SGX-ST for the time being in force (unless such compliance has been waived by the SGX-ST) and the Constitution for the time being of the Company; and

- immediately preceding the date of the making of the offer pursuant to the off-market purchase; "date of the making of the offer" means the date on which the Company announces its intention to make an offer for the purchase or acquisition of Shares from holders of Shares, stating therein the purchase price (which shall not be more than the Maximum Price) for each Share and the relevant terms of the equal access scheme for effecting the off-market purchase;
- "Maximum Limit" means that number of issued Shares representing 10% of the total number of issued Shares as at the date of the passing of this Resolution (excluding treasury shares and subsidiary holdings (as defined in the Listing Manual of the SGX-ST)); and

Item 3(a) - Subject to his re-election, Mr. Francis Yuen Tin Fan, who is a Non-Independent Non-Executive Director, will remain as the Deputy Chairman of the Board of Directors and a member of each of the Audit

Committee, Remuneration Committee and Nominating Committee

Item 3(b) - Subject to his re-election, Mr. Yeo Wee Kiong, who is an Independent Director, will remain as Chairman of the Audit Committee and a member of the Remuneration Committee. Item 3(c) - Subject to her re-election, Ms. Charlene Dawes, who is an Independent Director, will remain as a member of each of the Audit Committee and Nominating Committee.
